

COVID-19 Liability Waiver & Pre-screening Questionnaire

THIS IS A RELEASE OF LIABILITY. This waiver is entered into between the Participants on the reservation and WestWorld Tours from which you purchased your vacation tour. **In all cases, the participant signing this waiver acknowledges, consents to, accepts and agrees to all clauses listed below.**

WestWorld Tours cannot prevent participants from the potential of being exposed to, contracting, or spreading COVID-19 while using the services provided. Because of that, you are voluntarily participating in this tour with knowledge of the inherent risks of COVID-19, and you agree to assume all risks.

ASSUMPTION OF RISK

You are aware of the COVID-19 pandemic and related government laws, regulations, orders, directives, and guidelines including directives for frequent and thorough hand washing with soap and water, social distancing when possible, and use of facemasks in public locations when required. You are aware that participation in your tour activities is occurring in public locations, which may or may not have been affected by the COVID-19 pandemic.

You are aware that WestWorld Tours must abide by the laws and regulations of local, provincial, federal, and other national and international governments regarding the safety and spread of communicable diseases, which may include quarantine in a foreign location, at your expense, without physical access to family and friends and could result in trip interruption or cancellation.

You are aware that, where possible, WestWorld Tours will continue to implement policies intended to reduce the potential for the spread of COVID-19 and any other infectious disease, but that WestWorld Tours cannot guarantee that you, or members of your travelling party, will not become infected with COVID-19 or any other infectious disease as a result of participating in the tour.

To the extent permitted by law, you hereby:

1. Assume and agree to accept any and all risks related to COVID-19 during the course of your travel with WestWorld Tours on the tour
2. Release WestWorld Tours and its employees, directors, and agents, from any and all claims that may accordingly arise during the course of your participation in the tour.

COVID-19 Pre-Boarding Screening Questions

1. You have assessed yourself for COVID-19 related symptoms, and have experienced none of the following in the last 10 days prior the trips departure date (excluding pre-existing conditions not related to COVID-19):
 - A fever (temperature of 38°C/100.4°F or higher)
 - Shortness of breath/difficulty breathing
 - Chronic coughing
 - Sore throat
 - Diarrhea, vomiting and/or nausea
 - Recent loss of taste or smell
2. You have not been denied boarding by an airline due to COVID-19 exposure in the last 10 days.
3. You have not had close contact with someone who tested positive for COVID-19 or who has experienced symptoms of COVID-19 in the last 10 days.
